Environmental policy of the company.

In order to achieve continuous improvement of environmental behavior, in accordance with the company's vision and the overall company policy, quality policy and safety policy, the top management commits to:

- To comply with current environmental legal standards, regulations and other requirements when performing their activities.
- Constantly improve the environmental management system in accordance with international standards.
- Regularly identify environmental aspects, identify and review long-term and short-term goals, adopt preventive programs to eliminate environmental aspects;
- To create organizational and material conditions for compliance with the relevant legal and other requirements that the company has undertaken to meet;
- As part of pollution prevention, reduce or eliminate the impact of its activities and products on the environment by developing, designing and manufacturing products with a lower environmental impact;
- To protect the environment by reducing emissions into the air, reducing the amount of pollutants in water and soil, reduce the amount of greenhouse gas emissions by introducing new technologies and installing modern production equipment; create suitable conditions for soil and groundwater protection.
- To reduce and separate waste, to create conditions for the separation of waste arising from individual activities of the company, to reduce the volume of produced waste by prioritizing recovery before disposal.
- To reduce the consumption of energy and raw materials, by choosing more favorable chemical substances and mixtures, by more economical use of energy and material resources, to support the responsible sourcing of raw materials, materials and energy and thereby reduce costs, to focus its activities on renewable energy sources

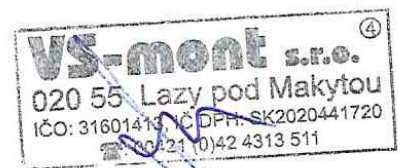
- Develop procedures for the prevention of the possibility of an emergency threat and an emergency situation;
